





Annual General Meeting of Lundin Petroleum AB 7 May 2015

The Annual General Meeting of Shareholders of Lundin Petroleum AB (publ) (the "Company") was held today Thursday 7 May 2015 in Stockholm.

The Company's and the Group's income statements and balance sheets for the financial year 2014 were adopted and the members of the Board of Directors and the Chief Executive Officer of the Company were discharged from liability for the financial year 2014.

The Meeting resolved that no dividends should be paid for the financial year 2014.

Peggy Bruzelius, C. Ashley Heppenstall, Ian H. Lundin, Lukas H. Lundin, William A. Rand, Magnus Unger and Cecilia Vieweg were re-elected as members of the Board of Directors and Grace Reksten Skaugen was elected as a new member of the Board of Directors. Asbjørn Larsen had declined re-election.

Ian H. Lundin was re-elected as chairman of the Board of Directors.

The Meeting resolved to remunerate the members of the Board of Directors as follows: (i) annual fees of the members of the Board of Directors of SEK 500,000 (excluding the Chairman of the Board of Directors and the Chief Executive Officer); (ii) annual fees of the Chairman of the Board of Directors of SEK 1,050,000; (iii) annual fees for Committee members of SEK 100,000 per Committee assignment (excluding the Committee Chairmen); and (iv) annual fees for Committee Chairmen of SEK 150,000; with the total fees for Committee work, including Committee Chairmen fees, not to exceed SEK 900,000. In addition, an amount of SEK 1,500,000 shall be paid to the Chairman of the Board of Directors for special assignments outside the directorship.

PricewaterhouseCoopers AB was re-elected as the auditor of the Company for a period until the 2016 Annual General Meeting. The Meeting resolved that auditors' fees shall be paid upon approval of their invoice.

Further, the Meeting resolved, in accordance with the Board of Directors' proposals:

- to approve the Company's 2015 Policy on Remuneration for Lundin Petroleum's Group Management, which includes four key elements of remuneration: a) base salary; b) yearly variable salary; c) Longterm Incentive Plan (LTIP); and d) other benefits;
- to approve the LTIP 2015 for members of Group Management and a number of key employees, which gives the participants the possibility to receive shares in Lundin Petroleum subject to uninterrupted employment and to the fulfilment of a performance condition over a three year performance period. The performance condition is based on the share price growth and dividends ("Total Shareholder Return") of the Lundin Petroleum share compared to the Total Shareholder Return of a peer group of companies. The total number of performance shares under LTIP 2015 as at the date of award may not exceed 900,000 and the maximum cost for granting awards under LTIP 2015, excluding costs related to delivery of the performance shares, is approximately USD 11.1 million (approximately SEK 96.0 million), excluding social security charges.
- to authorise the Board of Directors to issue new shares and/or convertible debentures corresponding to in total not more than 34,000,000 new shares, with or without the application of the shareholders preemption rights, in order to enable the Company to make business acquisitions or other major investments; and
- to authorize the Board of Directors to decide on repurchases and sales by the Company of its shares on NASDAQ Stockholm, where the number of shares so repurchased shall be limited so that shares held in treasury from time to time do not exceed five per cent of all outstanding shares of the Company.

Lundin Petroleum is a Swedish independent oil and gas exploration and production company with a well balanced portfolio of world-class assets primarily located in Europe and South East Asia. The Company is listed on NASDAQ Stockholm (ticker "LUPE"). Lundin Petroleum has proven and probable reserves of 187.5 million barrels of oil equivalent (MMboe).
